

LEGAL NOTICE - ORDINANCE NO. 190

AN ORDINANCE AMENDING CHAPTER 1, AN ORDINANCE REGULATING SOLID WASTE, RECYCLABLE AND ORGANIC MATERIALS, AND THE COLLECTION, REMOVAL AND DISPOSAL THEREOF, TITLE 4 – GARBAGE SERVICE, AS AMENDED, OF THE ORDINANCE CODE OF THE LAS GALLINAS VALLEY SANITARY DISTRICT

Pursuant to Health & Safety Code § 6490 and 6491.3, the Board of Directors of the Las Gallinas Valley Sanitary District, approved Ordinance No. 190 on December 15, 2022:

The Las Gallinas Valley Sanitary District has passed Ordinance 190 entitled An Ordinance Amending Chapter 1, an Ordinance Regulating Solid Waste, Recyclable and Organic Materials, and The Collection, Removal and Disposal Thereof, Title 4 – Garbage Service. The ordinance amends Appendix A of Title 4, Chapter 1 to increase the refuse collection rates effective January 1, 2023 by 6.17%.

The most common residential, multi-family and commercial services will be increased as follows:
